A.3 Insignificant Activities [326 IAC 2-7-1(21)] [326 IAC 2-8-3(c)(3)(I)]

SECTION B GENERAL CONDITIONS

B.1 Permit No Defense [IC 13]

Indiana statutes from IC 13 and rules from 326 IAC, quoted in conditions in this permit, are those applicable at the time the permit was issued. The issuance or possession of this permit shall not alone constitute a defense against an alleged violation of any law, regulation or standard, except for the requirement to obtain a FESOP under 326 IAC 2-8.

B.2 Definitions [326 IAC 2-8-1]

Terms in this permit shall have the definition assigned to such terms in the referenced regulation. In the absence of definitions in the referenced regulation, the applicable definitions found in the statutes or regulations (IC 13-11, 326 IAC 1-2, and 326 IAC 2-7) shall prevail.

B.3 Permit Term [326 IAC 2-7-5(2)] [326 IAC 2-1.1-9.5]

This permit is issued for a fixed term of five (5) years from the issuancel date of this permit, as determined in accordance with IC 4-21.5-3-5(f) and IC 13-15-5-3. Subsequent revisions, modifications, or amendments of this permit do not affect the expiration date.

B.4 Enforceability [326 IAC 2-8-6]

- (a) Unless otherwise stated, all terms and conditions in this permit, including any provisions designed to limit the source's potential to emit, are enforceable by IDEM and OES, the United States Environmental Protection Agency (U.S. EPA) and by citizens in accordance with the Clean Air Act.
- (b) Unless otherwise stated, all terms and conditions in this permit that are local requirements, including any provisions designed to limit the source's potential to emit, are enforceable by OES.

B.5 Termination of Right to Operate [326 IAC 2-8-9] [326 IAC 2-8-3(h)]

The Permittee's right to operate this source terminates with the expiration of this permit unless a timely and complete renewal application is submitted at least nine (9) months prior to the date of expiration of the source's existing permit, consistent with 326 IAC 2-8-3(h) and 326 IAC 2-8-9.

The provisions of this permit are severable; a determination that any portion of this permit is invalid shall not affect the validity of the remainder of the permit.

- (c) For information furnished by the Permittee to IDEM, OAQ, the Permittee may include a claim of confidentiality in accordance with 326 IAC 17. When furnishing copies of requested records directly to U. S. EPA, the Permittee may assert a claim of confidentiality in accordance with 40 CFR 2, Subpart B.

B.9 Compliance Order Issuance [326 IAC 2-8-5(b)]

IDEM, OAQ and/or OES may issue a compliance order to this Permittee upon discovery that this permit is in nonconformance with an applicable requirement. The order may require immediate compliance or contain a schedule for expeditious compliance with the applicable requirement.

B.10 Compliance with Permit Conditions [326 IAC 2-8-4(5)(A)] [326 IAC 2-8-4(5)(B)]

- (a) The Permittee must comply with all conditions of this permit. Noncompliance with any provisions of this permit is grounds for:
 - (1) Enforcement action;
 - (2) Permit termination, revocation and reissuance, or modification; and

- (b) It shall not be a defense for the Permittee in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of this permit.

The PMP extension notification does not require the certification by the "authorized individual" as defined by 326 IAC 2-1.1-1(1).

- (b) The Permittee shall implement the PMPs as necessary to ensure that failure to implement a PMP does not cause or contribute to a violation of any limitation on emissions or potential to emit.
- (c) A copy of the PMPs shall be submitted to IDEM, OAQ and/or OES upon request and within a reasonable time, and shall be subject to review and approval by IDEM, OAQ and/or OES. IDEM, OAQ and/or OES may require the Permittee to revise its PMPs whenever lack of proper maintenance causes or contributes to any violation. - (d) Records of preventive maintenance shall be retained for a period of at least five (5) years. These records shall be kept at the source location for a minimum of three (3) years. If the Commissioner or OES makes a request for records to the Permittee, the Permittee shall furnish the records to the Commissioner and/or OES within a reasonable time.

Entire Source

Emissions Limitations and Standards [326 IAC 2-8-4(1)]

- C.1 Particulate Emission Limitations For Processes with Process Weight Rates Less Than One Hundred (100) pounds per hour [40 CFR 52 Subpart P][326 IAC 6-3-2]
 - (a) Pursuant to 40 CFR 52 Subpart P, the allowable particulate matter emissions rate from any process not already regulated by 326 IAC 6-1 or any New Source Performance Standard, and which has a maximum process weight rate less than 100 pounds per hour shall not exceed 0.551 pounds per hour.

C.2 Overall Source Limit [326 IAC 2-8]

The purpose of this permit is to limit this source's potential to emit to less than major source levels for the purpose of Section 502(a) of the Clean Air Act.

- (a) Pursuant to 326 IAC 2-8:
 - (1) The potential to emit any regulated pollutant, except particulate matter (PM), from the entire source shall be limited to less than one-hundred (100) tons per twelve (12) consecutive month period. - (b) This condition shall include all emission points at this source including those that are insignificant as defined in 326 IAC 2-7-1(21). The source shall be allowed to add insignificant activities not already listed in this permit, provided that the source's potential to emit does not exceed the above specified limits.
- (c) Section D of this permit contains independently enforceable provisions to satisfy this requirement.

C.3 Opacity [326 IAC 5-1]

Pursuant to 326 IAC 5-1-2 (Opacity Limitations), except as provided in 326 IAC 5-1-3 (Temporary Alternative Opacity Limitations), opacity shall meet the following, unless otherwise stated in this permit:

- (a) Opacity shall not exceed an average of thirty percent (30%) in any one (1) six (6) minute averaging period as determined in 326 IAC 5-1-4.
- (b) Opacity shall not exceed sixty percent (60%) for more than a cumulative total of fifteen (15) minutes (sixty (60) readings as measured according to 40 CFR 60, Appendix A, Method 9

C.4 Open Burning [326 IAC 4-1] [IC 13-17-9]

The Permittee shall not open burn any material except as provided in 326 IAC 4-1-3, 326 IAC 4-1-4 or 326 IAC 4-1-6. The previous sentence notwithstanding, the Permittee may open burn in accordance with an open burning approval issued by the Commissioner under 326 IAC 4-1-4.1.

C.5 Incineration [326 IAC 4-2] [326 IAC 9-1-2(3)]

The Permittee shall not operate an incinerator or incinerate any waste or refuse except as provided in 326 IAC 4-2 and in 326 IAC 9-1-2.

C.6 Fugitive Dust Emissions [326 IAC 6-4]

The Permittee shall not allow fugitive dust to escape beyond the property line or boundaries of the property, right-of-way, or easement on which the source is located, in a manner that would violate 326 IAC 6-4 (Fugitive Dust Emissions).

C.7 Operation of Equipment [326 IAC 2-8-5(a)(4)]

Except as otherwise provided by statute, rule or in this permit, all air pollution control equipment listed in this permit and used to comply with an applicable requirement shall be operated at all times that the emission units vented to the control equipment are in operation.

C.8 Asbestos Abatement Projects [326 IAC 14-10] [326 IAC 18] [40 CFR 61, Subpart M]

- (a) Notification requirements apply to each owner or operator. If the combined amount of regulated asbestos containing material (RACM) to be stripped, removed or disturbed is at least 260 linear feet on pipes or 160 square feet on other facility components, or at least thirty-five (35) cubic feet on all facility components, then the notification requirements of 326 IAC 14-10-3 are mandatory. All demolition projects require notification whether or not asbestos is present.
- (b) The Permittee shall ensure that a written notification is sent on a form provided by the Commissioner at least ten (10) working days before asbestos stripping or removal work or before demolition begins, per 326 IAC 14-10-3, and shall update such notice as necessary, including, but not limited to the following:
 - (1) When the amount of affected asbestos containing material increases or decreases by at least twenty percent (20%); or

 - (C) Waste disposal site.

An extension may be granted by IDEM, OAQ, if the source submits to IDEM, OAQ, a reasonable written explanation not later than five (5) days prior to the end of the initial forty-five (45) day period.

C.10 Compliance Requirements [326 IAC 2-1.1-11]

The commissioner may require stack testing, monitoring, or reporting at any time to assure compliance with all applicable requirements by issuing an order under 326 2-1.1-11. Unless otherwise specified in the approval for the new emissions unit, compliance monitoring for new emission units or emission units added through a permit revision shall be implemented when operation begins.

C.12 Monitoring Methods [326 IAC 3] [40 CFR 60] [40 CFR 63]

Any monitoring or testing performed required by Section D of this permit shall be performed according to the provisions of 326 IAC 3, 40 CFR 60, Appendix A, 40 CFR 60 Appendix B, 40 CFR 63 or other approved methods as specified in this permit.

Corrective Actions and Response Steps [326 IAC 2-8-4] [326 IAC 2-8-5(a)(1)]

C.13 Emergency Reduction Plans [326 IAC 1-5-2] [326 IAC 1-5-3]

Pursuant to 326 IAC 1-5-2 (Emergency Reduction Plans; Submission):

- (a) The Permittee prepared and submitted written emergency reduction plans (ERPs) consistent with safe operating procedures on November 16, 1988.
- (b) Upon direct notification by IDEM, OAQ and/or OES that a specific air pollution episode level is in effect, the Permittee shall immediately put into effect the actions stipulated in the approved ERP for the appropriate episode level. [326 IAC 1-5-3]

C.14 Risk Management Plan [326 IAC 2-8-4] [40 CFR 68.215]

If a regulated substance, subject to 40 CFR 68, is present at a source in more than a threshold quantity, 40 CFR 68 is an applicable requirement and the Permittee shall submit:

(a) A compliance schedule for meeting the requirements of 40 CFR 68; or

- (a) The Permittee is required to prepare a Compliance Response Plan (CRP) for each compliance monitoring condition of this permit. A CRP shall be submitted to IDEM, OAQ, and OES upon request. The CRP shall be prepared within ninety (90) days after issuance of this permit by the Permittee, supplemented from time to time by the Permittee, maintained on site, and comprised of:
 - (1) Reasonable response steps that may be implemented in the event that a response step is needed pursuant to the requirements of Section D of this permit; and an expected time frame for taking reasonable response steps.
 - (2) If, at any time, the Permittee takes reasonable response steps that are not set forth in the Permittee's current Compliance Response Plan and the Permittee documents such response in accordance with subsection (e) below, the Permittee shall amend its Compliance Response Plan to include such response steps taken.
- (b) For each compliance monitoring condition of this permit, reasonable response steps shall be taken when indicated by the provisions of that compliance monitoring condition as follows:
 - (1) Reasonable response steps shall be taken as set forth in the Permittee's current Compliance Response Plan; or
 - (2) If none of the reasonable response steps listed in the Compliance Response Plan is applicable or responsive to the excursion, the Permittee shall devise and implement additional response steps as expeditiously as practical. Taking such additional response steps shall not be considered a deviation from this permit so long as the Permittee documents such response steps in accordance with this condition.
 - (3) If the Permittee determines that additional response steps would necessitate that the emissions unit or control device be shut down, the IDEM, OAQ shall be promptly notified of the expected date of the shut down, the status of the applicable compliance monitoring parameter with respect to normal, and the results of the actions taken up to the time of notification.
 - (4) Failure to take reasonable response steps shall constitute a violation of the permit.
- (c) The Permittee is not required to take any further response steps for any of the following reasons:
 - (1) A false reading occurs due to the malfunction of the monitoring equipment and prompt action was taken to correct the monitoring equipment.
 - (2) The Permittee has determined that the compliance monitoring parameters established in the permit conditions are technically inappropriate, has previously submitted a request for an administrative amendment to the permit, and such request has not been denied.

- (3) An automatic measurement was taken when the process was not operating.
- (4) The process has already returned or is returning to operating within "normal" parameters and no response steps are required.
- (d) When implementing reasonable steps in response to a compliance monitoring condition, if the Permittee determines that an exceedance of an emission limitation has occurred, the Permittee shall report such deviations pursuant to Section B-Deviations from Permit Requirements and Conditions.
- (e) The Permittee shall record all instances when response steps are taken. In the event of an emergency, the provisions of 326 IAC 2-8-12 (Emergency Provisions) requiring prompt corrective action to mitigate emissions shall prevail.
- (f) Except as otherwise provided by a rule or provided specifically in Section D, all monitoring as required in Section D shall be performed when the emission unit is operating, except for time necessary to perform quality assurance and maintenance activities.

C.16 Actions Related to Noncompliance Demonstrated by a Stack Test [326 IAC 2-8-4] [326 IAC 2-8-5]

- (a) When the results of a stack test performed in conformance with Section C Performance Testing, of this permit exceed the level specified in any condition of this permit, the Permittee shall take appropriate response actions. The Permittee shall submit a description of these response actions to IDEM, OAQ, within thirty (30) days of receipt of the test results. The Permittee shall take appropriate action to minimize excess emissions from the affected facility while the response actions are being implemented.
- (b) A retest to demonstrate compliance shall be performed within one hundred twenty (120) days of receipt of the original test results. Should the Permittee demonstrate to IDEM, OAQ that retesting in one-hundred and twenty (120) days is not practicable, IDEM, OAQ may extend the retesting deadline.
- (c) IDEM, OAQ reserves the authority to take any actions allowed under law in response to noncompliant stack tests.

The documents submitted pursuant to this condition do require the certification by the "authorized individual" as defined by 326 IAC 2-1.1-1(1).

Compliance with the potential to emit limitation makes 326 IAC 2-7 (Part 70 Permit Program) not applicable.
 - (b) For purposes of determining compliance based on SO₂ emissions, every one (1) million cubic feet (MMCF) of natural gas shall be equivalent to 0.0086 Kilo-gallons (Kgal) of No. 2 oil.
- D.1.2 Sulfur Dioxide Emissions Limitations [326 IAC 7-1.1-2] [40 CFR 60.42, Subpart Dc] [326 IAC 12]

 Pursuant to 326 IAC 7-1.1-2, the sulfur content of fuel oil combusted in the three (3) 20.25 million

 Btu per hour Nebraska Boilers (EU1, EU2, and EU3) shall be limited to 0.5 pounds per million Btu

- Where Pt = Pounds of PM emitted per million Btu(lb/mmBtu) heat input. Pt is equivalent to 0.37 lbs/mmBtu or 7.49 lbs/hr at maximum heat input capacity.
 - Q = Total source maximum operating capacity rating in mmBtu per hour heat input. Q is equivalent to 60.75 MMBtu per hour in the case that all three boilers are operating simultaneously.

D.1.4 Preventive Maintenance Plan [326 IAC 2-8-4(9)] [326 IAC 1-6-3]

A Preventive Maintenance Plan, in accordance with Section B - Preventive Maintenance Plan, of this permit, is required for the three (3) 20.25 MMBtu per hour Nebraska Boilers.

Compliance Determination Requirements

D.1.5 Sulfur Dioxide Emissions and Sulfur Content [326 IAC 3-7-4]

When fueled by distillate oil, compliance shall be determined utilizing one of the following options.

- (a) Pursuant to 326 IAC 3-7-4, the Permittee shall demonstrate that the sulfur dioxide emissions do not exceed five-tenths (0.5) pounds per million Btu heat input by:
 - (1) Providing vendor analysis of fuel delivered, if accompanied by a vendor certification; or

- (b) Compliance may also be determined by conducting a stack test for sulfur dioxide emissions from the two (2.0) MMBtu per hour heater, using 40 CFR 60, Appendix A, Method 6 in accordance with the procedures in 326 IAC 3-6.

A determination of noncompliance pursuant to any of the methods specified in (a) or (b) above shall not be refuted by evidence of compliance pursuant to the other method.

Compliance Monitoring Requirements [326 IAC 2-8-5(a)(1)]

D.1.6 Visible Emissions Notations

- (a) Visible emission notations shall be performed once per shift during normal daylight operations when combusting fuel oil in any one of the three (3) 20.25 million Btu per hour Nebraska Boilers (EU1, EU2, and EU3). A trained employee shall record whether emissions are normal or abnormal.
- (b) For processes operated continuously, "normal" means those conditions prevailing, or expected to prevail, eighty percent (80%) of the time the process is in operation, not counting startup or shut down time.
- (c) In the case of batch or discontinuous operations, readings shall be taken during that part of the operation that would normally be expected to cause the greatest emissions.
- (d) A trained employee is an employee who has worked at the plant at least one (1) month and has been trained in the appearance and characteristics of normal visible emissions for that specific process.
- (e) The Compliance Response Plan for this unit shall contain troubleshooting contingency and response steps for when an abnormal emission is observed. Failure to take response steps in accordance with Section C- Compliance Response Plan Preparation, Implementation, Records and Reports, shall be considered a violation of this permit.

 - (6) A certification, signed by the owner or operator, that the records of the fuel supplier certifications or results of fuel oil analysis represent all of the distillate or residual fuel combusted during the period.

The fuel supplier certification shall contain, as a minimum, the following:

- (7) The name of the fuel supplier; and
- (8) A statement from the fuel supplier that certifies the sulfur content of the fuel oil.

The Permittee shall retain records of all recording/monitoring data and support information for a period of five (5) years, or longer if specified elsewhere in this permit, from the date of the monitoring sample, measurement, or report. Support information includes all calibration and maintenance records and all original strip-chart recordings for continuous monitoring instrumentation, and copies of all reports required by this permit.

- (b) To document compliance with Condition D.1.6, the Permittee shall maintain records of visible emission notations of the stack exhaust once per shift.
- (c) All records shall be maintained in accordance with Section C General Record Keeping Requirements, of this permit.

D.1.8 Reporting Requirements

A quarterly summary of the information to document compliance with Conditions D.1.1 and D.1.2 shall be submitted to the addresses listed in Section C - General Reporting Requirements, of this permit, using the reporting forms located at the end of this permit, or their equivalent, within thirty (30) days after the end of the quarter being reported.  - (4) The Production Paint Booth 4, emission unit 7, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 4 is used to coat avionics equipment. This booth was constructed in 1987. Emissions from Production Paint booth 4 is vented out stack identified as stack/vent S₇.
 - (5) The Aircraft Armament Equipment Paint Shop, emission unit 8, is equipped with an airless atomized sprayer with a dry filter to control over spray. This paint booth is used to coat avionics equipment. This booth was installed in 1995. Emission are vented out one stack identified as Stack vent S₈
 - (6) The Production Paint Booth 5, emission unit 10, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 5 is used to coat avionics equipment. This booth was constructed in 1998. Emissions from Production Paint booth 5 is vented out stack identified as stack/vent S₁₀.

Emissions Limitations and Standards [326 IAC 2-8-4(1)]

D.2.1 VOC and HAP FESOP Limit [326 IAC 2-8-4] [326 IAC 8-2-9] [326 IAC 2-2] [40 CFR 52.21]

- (a) The VOC emissions from each paint booth (EU4-EU8, and EU10) are limited to less than fifteen (15) pounds per day each, such that the requirements of 326 IAC 8-2-9 (Miscellaneous Metal Coating Operations) shall not apply. Compliance with these limits render the requirements of 326 IAC 2-7 (Part 70 Permit Program), 326 IAC 8-2-9, (Miscellaneous Metal Coating Operations) and 326 IAC 2-2 (PSD) not applicable.
- (b) The amount of any single HAP delivered to the six (6) paint booths (EU4-EU8, and EU10) shall be limited to less than three and four tenths (3.4) tons per twelve (12) consecutive month period with compliance determined at the end of each month. The amount of any combination of HAPs delivered to the paint booths shall be less than eight and two tenths (8.2) tons per twelve (12) consecutive month period with compliance determined at the end of each month. These limits are structured such that when including the emissions of the insignificant activities, the total source single HAP emissions remain below ten (10) tons

D.2.2 Particulate Matter [40 CFR 52, Subpart P]

D.2.3 Particulate [326 IAC 6-3-2(d)]

Pursuant to F097-5444-00100, issued on October 30, 1997 and 326 IAC 6-3-2(d), particulate from the six (6) paint booths (EU4-EU8, and EU10) shall be controlled by a dry particulate filter, and the Permittee shall operate the control device in accordance with manufacturer's specifications.

D.2.4 Preventive Maintenance Plan [326 IAC 2-8-4(9)] [326 IAC 1-6-3]

A Preventive Maintenance Plan, in accordance with Section B - Preventive Maintenance Plan, of this permit, is required for each of the six (6) paint booths (EU4-EU8 and EU10).

D.2.5 Volatile Organic Compounds

Failure to take response steps in accordance with Section C Compliance Response Plan -Preparation, Implementation, Records, and Reports, shall be considered a violation of this permit.
- (c) Additional inspections and preventive measures shall be performed as prescribed in the Preventive Maintenance Plan.

On March 21, 2003, the Office of Environmental Services (OES) had a notice published in the Indianapolis Star Newspaper, Indianapolis, Indiana, stating that Raytheon Technical Services Co. had applied for a Federally Enforceable State Operating Permit (FESOP) Renewal to operate a hot mix asphalt plant. The notice also stated that OES and Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ) proposed to issue a permit for this operation and provided information on how the public could review the proposed permit and other documentation. Finally, the notice informed interested parties that there was a period of thirty (30) days to provide comments on whether or not this permit should be issued as proposed.

The following changes, to the draft FESOP Renewal Permit, will be made. The TSD will remain as it originally appeared when published. These changes have no effect on the limited potential to emit (PTE) for this source. OES and OAQ prefers that the Technical Support Document reflect the permit that was on public notice. Changes to the permit or technical support material that occur after the permit has been published are documented in this Addendum to the Technical Support Document. This accomplishes the desired result of ensuring that these types of concerns are documented and part of the record regarding this permit decision.

Upon further review, the OES has decided to make the following revisions to the permit (bolded language has been added, the language with a line through it has been deleted). The Table Of Contents has been modified to reflect these changes.

Condition A.3 <u>Insignificant Activities</u>. The IAC reference to the definition of a laboratory under A.3
(q) was incorrectly cited as 326 IAC 2-7-1(20)(C) when it should have been cited as 326 IAC 2-7-1(21)(D). This change does not affect the limited potential to emit. The condition has been updated to include the correction:

A.3 Insignificant Activities [326 IAC 2-7-1(21)] [326 IAC 2-8-3(c)(3)(I)]

This stationary source also includes the following insignificant activities, as defined in 326 IAC 2-7-1(21):

(q) A laboratory as defined in 326 IAC 2-7-1 (20)(C) (21)(D).

2. Condition D.1.1 <u>Particulate Emissions (PM)</u>. A portion of the definition of "Q" was inadvertantly excluded from the permit. The definition was complete in the TSD. The permit has been changed to include the entire definition as it written in the TSD. This change does not affect the limited potential to emit:


D.1.3 Particulate Emissions (PM) [326 IAC 6-2-4]

The three (3) Nebraska Boilers (EU1, EU2, and EU3) are subject to the PM limits in 326 IAC 6-2-4. This regulation applies since these units do not have actual PM emissions greater than 10 tons per year, are used for indirect heating, and were all installed after September 21, 1983. Pursuant to 326 IAC 6-2-4, particulate matter (PM) emissions shall be limited by the following equation


$$Pt = \frac{1.09}{0^{0.26}}$$

- Where Pt = Pounds of PM emitted per million Btu(lb/mmBtu) heat input. Pt is equivalent to 0.37 lbs/mmBtu or 7.49 lbs/hr at maximum heat input capacity.
 - Q = Total source maximum operating capacity rating in mmBtu per hour heat input. Q is equivalent to 60.75 MMBtu per hour since in the case that all three boilers were operating simultaneously.
- Condition D.1.1 <u>Volatile Organic Compounds (VOC)</u>. This condition refers to 326 IAC 8-3-5 (Cold Cleaner Operation) which is applicable to degreasing operations constructed after 1980. The degreaser at this source existed prior to 1980. Therefore this condition is being removed. This change does not affect the limited potential to emit. The permit has been changed as follows:

D.3.2 Volatile Organic Compounds (VOC) [326 IAC 8-3-5]



(2) Equip the degreaser with a facility for draining cleaned articles. If the solvent volatility is greater than four and three-tenths (4.3) kiloPascals (thirty-two (32) millimeters of mercury) or six-tenths (0.6) pounds per square inch) measured at thirty-eight degrees Celsius (38°C) (one hundred degrees Fahrenheit (100°F)), then the drainage facility must be internal such that articles are enclosed under the cover while draining. The drainage facility may be external for applications where an internal type cannot fit into the cleaning system.



- 4. Under the "Existing Approval" section on page 3 of 12 in the TSD, the sentence "All conditions form previous approvals were incorporated into this Part 70 permit except for the following:" should have been written "All conditions form previous approvals were incorporated into this Renewal except for the following:"
- 5. The date reported for submittal of the Emergency Reduction Plan (ERP) under 326 IAC 1-5-2 on page 7 of 12 of the TSD has changed. During the Renewal public notice period, the source submitted an updated ERP. The new ERP submittal date is May 1, 2003.
- 6. Under the "State Rule Applicability Entire Source" section on page 8 of 12 of the TSD, the last sentence in 326 IAC 2-8-4 (b) reads, "Compliance with these limits render the requirements of 326 IAC 2-7 (Part 70 Permit Program)." This should have been written, "Compliance with these limits render the requirements of 326 IAC 2-7 (Part 70 Permit Program) not applicable."
- 7. The applicability of 326 IAC 8-3-5 was incorrectly explained on page 11 of 12 in the TSD. The source is not subject to 326 IAC 8-3-5 because the degreasing facility existed prior to January 1980.

- (b) The Production Paint Booths 1-5, identified as emission units 4 through 7 and 10, and the Aircraft Armament Equipment Paint Shop, identified as emission unit 8.
 - (1) The Production Paint Booth 1, emission unit 4, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 1 is used to coat avionics equipment. This booth was constructed in 1987. Emissions from Production Paint booth 1 is vented out stack identified as stack S_4 .
 - (2) The Production Paint Booth 2, emissions unit 5, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 2 is used to coat avionics equipment. This booth was constructed in 1987. Emissions from Production Paint booth 2 is vented out stack identified as stack S_5 .
 - (3) The Production Paint Booth 3, emission unit 6, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 3 is used to coat avionics equipment. This booth was constructed in 1987. Emissions from Production Paint booth 3 is vented out stack identified as stack S₆.

- (4) The Production Paint Booth 4, emission unit 7, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 4 is used to coat avionics equipment. This booth was constructed in 1987. Emissions from Production Paint booth 4 is vented out stack identified as stack S₇.
- (5) The Aircraft Armament Equipment Paint Shop, emission unit 8, is equipped with an airless atomized sprayer with a dry filter to control over spray. This paint booth is used to coat avionics equipment. This booth was installed in 1995. Emission are vented out one stack identified as stack S₈
- (6) The Production Paint Booth 5, emission unit 10, is equipped with one atomized airless spray gun and a dry filter to control particulate emissions from over spray. Production Paint Booth 5 is used to coat avionics equipment. This booth was constructed in 1998. Emissions from Production Paint booth 5 is vented out stack identified as stack S₁₀.

Unpermitted Emission Units and Pollution Control Equipment

There are no unpermitted facilities operating at this source during this review process.

Insignificant Activities

- (a) A gasoline fuel transfer and dispensing operation handling less than or equal to 1,300 gallons per day, such as filling of tanks, automobiles, having a storage capacity less than or equal to 10,500 gallons;
- (b) A petroleum fuel, other than gasoline dispensing facility, having a storage capacity of less than or equal to 10,500 gallons, and dispensing less than or equal to 230,000 gallons per month;
- (c) Vessels storing lubricating oils, hydraulic oils, machining oils and machining fluids;
- (d) Machining where an aqueous cutting coolant continuously floods the machining interface;
- (e) Cold degreasing operations that do not exceed 145 gallons per 12 months, except if subject to 326 IAC 20-6, these operations are subject to 326 IAC 8-3-2 and 326 IAC 8-3-5;
- (f) Cleaners and solvents characterized as follows:
 - (1) having a vapor pressure equal to or less than 2 kPa; 15 mm Hg; or 0.3 psi measured at 38 degrees C (100 F) or;
 - (2) having a vapor pressure equal to or less than 0.7 kPa; 5 mm Hg; or 0.1 psi measured at 20 C (68 F);

the use of which for all cleaners and solvents combined does not exceed 145 gallons per 12 months;

- (g) The following equipment related to manufacturing activities not resulting in emissions of HAPs: brazing equipment, cutting torches, soldering equipment, welding equipment;
- (h) Activities associated with the treatment of waste streams with an oil and grease content less than or equal to 1% by volume;
- (i) Forced and induced draft cooling tower systems not regulated under a NESHAP;
- (k) Paved and unpaved roads and parking lots with public access;
- (I) Asbestos abatement projects regulated by 326 IAC 14-10;

- (m) Equipment used to collect any material that might be released during a malfunction, process upset, or spill cleanup, including catch tanks, temporary liquid separators, tanks, and fluid handling equipment;
- (n) Blowdown for any of the following: sight glass: boiler; compressors; pumps and cooling towers:
- (o) Furnaces used for melting metals other than berylium with a brim full capacity of less than or equal to 450 cubic inches by volume;
- (p) Emergency generators as follows:
 Diesel generators not exceeding 1600 horse power;
- (q) A laboratory as defined in 326 IAC 2-7-1(20)(C).

Existing Approvals

The source has been operating under previous approvals including, but not limited to, the following:

- (a) FESOP 097-5444-00100, issued on October 30, 1997; and expiring on October 30, 2002, and;
- (b) First Minor Permit Modification 097-9973-00100, issued on September 10, 1998.

The following emission unit description has been removed from this Renewal:

(a) Deburring operation, identified as emission unit 9. This facility was installed in 1982. The particulate emissions from this unit are controlled by a venturi scrubber which exhausts out one stack identified as S₉.

All conditions from previous approvals were incorporated into this Part 70 permit except for the following:

(a) D.3.1 Particulate Matter

The venturi scrubber shall be in operation at all times when the deburring process is in operation. The particulate matter emissions from this facility shall not exceed 0.55 pounds per hour pursuant to 326 IAC 6-3-2(c).

Interpolation and extrapolation of the data for the process weight rate up to sixty thousand (60,000) pounds per hour shall be accomplished by use of the equation:

$$E = 4.10 P^{0.67}$$
 where $E =$ rate of emission in pounds per hour and $P =$ process weight rate in tons per hour

D.3.2 Preventive Maintenance Plan [326 IAC 2-8-4(9)]

A Preventive Maintenance Plan, in accordance with Section B - Preventive Maintenance Plan, of this permit, is required for this facility and its control device.

D.3.3 Testing Requirements [326 IAC 2-8-5(1)]

Compliance with the PM emission limitations established in condition D.1.2 shall be determined based on stack testing. Testing of this facility is not specifically required by this permit. However, this does not preclude testing requirements on this facility under 326 IAC 2-1-4(f) and 326 IAC 2-8-4.

D.3.4 Particulate Matter (PM) Emissions

The venturi scrubber shall be in operation at all times when the deburring facility is in operation.

D.3.5 Visible Emission Notations

- (a) Weekly visible emission notations shall be preformed during normal daylight operations when the deburring facility is in operation. A trained employee shall record whether emissions are normal or abnormal.
- (b) For processes operated continuously, "normal" means those conditions prevailing, or expected to prevail, eighty percent (80%) of the time the process is in operation, not counting startup or shut down time.
- (c) In the case of batch or discontinuous operations, readings shall be taken during that part of the operation that would normally be expected to cause the greatest emissions.
- (d) A trained employee is an employee who has worked at the plant at least one (1) month and has been trained in the appearance and characteristics of normal visible emissions for that specific process.
- (e) The Preventive Maintenance Plan for this unit shall contain troubleshooting contingency and corrective actions for when an abnormal emission is observed.

D.3.6 Record Keeping Requirements

- (a) To document compliance with Condition D.3.5, the Permittee shall maintain a log of weekly visible emissions notations, and those additional inspections prescribed by the Preventative Maintenance Plan.
- (b) All records shall be maintained in accordance with Section C General Record Keeping Requirements, of this permit.

Reason not incorporated: All of the above conditions applied to the deburring operation (EU-9) which has been removed. Therefore these conditions contained within Section D.3 are no longer applicable.

Emission Calculations

Emission calculations for this source can be found in Appendix A, pages 1 through 4 of 4.

Recommendation

The staff recommends to the Administrator that the FESOP Renewal be approved. This recommendation is based on the following facts and conditions:

Unless otherwise stated, information used in this review was derived from the application and additional information submitted by the applicant.

An administratively complete FESOP Renewal application for the purposes of this review was received on July 27, 2001.

- (a) The potential to emit (as defined in 326 IAC 2-1.1-1(16)) of VOC and SO₂ is equal to or greater than 100 tons per year. Therefore, the source is subject to the provisions of 326 IAC 2-7.
- (b) The potential to emit (as defined in 326 IAC 2-1.1-1(16)) of any single HAP is equal to or greater than ten (10) tons per year and the potential to emit (as defined in 326 IAC 2-1.1-1(16)) of a combination HAPs is greater than or equal to twenty-five (25) tons per year. Therefore, the source is subject to the provisions of 326 IAC 2-7.
- (c) Fugitive Emissions
 Since this type of operation is one of the listed source categories under 326 IAC 2-2-1(w)(2)
 and since there are applicable New Source Performance Standards that were in effect on

Potential to Emit After Issuance

The source, issued a FESOP on October 30, 1997, has opted to remain a FESOP source, rather than apply for a Part 70 Operating Permit. Any control equipment is considered enforceable only after issuance of this Federally Enforceable State Operating Permit and only to the extent that the effect of the control equipment is made practically enforceable in the permit. The source's potential to emit is based on the emission units included in the original FESOP (F097-5444-00100; issued on May 28, 1998), First Minor Permit Modification (MMF097-9973-00100; issued September 10, 1998), and the removal of emission unit 9 which is being incorporated into this Renewal.

(a) Volatile organic compounds (VOC) are precursors for the formation of ozone. Therefore, VOC emissions are considered when evaluating the rule applicability relating to the ozone standards. Marion County has been designated as attainment or unclassifiable for ozone.

Federal Rule Applicability

- (a) The (3) three 20.25 MMBtu per hour boiler (EU1, EU2 and EU3) are subject to the New Source Performance Standard for Small Industrial Commercial Institutional Steam Generator Units, 40 CFR Part 60.40c, Subpart Dc (312 IAC 12), because they were constructed after June 9, 1989 and have heat input capacities greater than 10 million Btu per hour. The NSPS limits the sulfur content of fuel oil combusted to no greater than 0.5 percent by weight and subjects the source to the reporting and recordkeeping requirements described under 40 CFR Part 60.48c, Subpart Dc.
- (b) The two (2) storage vessels used as fuel transfer and dispensing facilities and listed as insignificant activities are not subject to the NSPS, 40 CFR Part 60.110b through 60.117b Subpart Kb (326 IAC 12) because this rule only applies to storage vessels with capacity

greater than or equal to forty (40) cubic meters (m^3) and these storage vessels have capacity less than forty (40) m^3 .

- (c) There are no National Emission Standards for Hazardous Air Pollutants (NESHAPs)(326 IAC 14 and 40 CFR Part 63) applicable to this source.
 - (1) The cold degreasing operations are not subject to 40 CFR Part 63.460, Subpart T (NESHAPs) (326 IAC 14 and 40 CFR Part 63) because the source does not operate a batch vapor, in-line vapor, in-line cold, and batch cold solvent cleaning machine.

State Rule Applicability - Entire Source

326 IAC 1-5-2 (Emergency Reduction Plan)

The source has submitted an Emergency Reduction Plan (ERP) on November 16, 1988. The ERP has been verified to fulfill the requirements of 326 IAC 1-5-2 (Emergency Reduction Plan).

326 IAC 1-6-3 (Preventative Maintenance Plan)

Pursuant to 326 IAC 1-6-1 and 326 IAC 1-6-3, a Preventative Maintenance Plan (PMP) should have been developed for each facility that was formerly permitted as a registration level. Since this source is regulated under 326 IAC 2-8 IDEM, OAQ and OES have established the following guidelines for determining if a facility is required to develop a PMP:

Preventative Maintenance Plans (PMP) are required for all emitting units which emit PM, SO₂, or VOC with existing applicable requirements and;

- (a) a NSPS or NESHAP applies; or
- the unit has a control device and allowable emissions exceed 10 pounds per hour;
 or
- (c) the unit does not have a control and actual emissions exceed 25 tons per year; or
- (d) the unit would have been subject to an applicable requirement if there was not a condition limiting the PTE

Based on IDEM, OAQ and OES review, a PMP is required for the three (3) Nebraska boilers (EU1, EU2, and EU3) because the units are subject to the NSPS, 40 CFR 60.40c, Subpart Dc (312 IAC 12).

A PMP is also required for each of the six (6) paint booths (EU4-EU8 and EU10) because the units have a control and allowable emissions exceed 10 pounds per hour.

326 IAC 2-2-2 (Prevention of Significant Deterioration)

The source commenced construction prior to the applicability date of August 7, 1977, and therefore does predate this rule. The source is not on the list of twenty-eight (28) listed source categories. The potential emissions from the coating operations are greater than major threshold levels, however actual VOC emissions have never exceeded major threshold levels. The source has accepted limits such that the requirements of 326 IAC 2-2 and 40 CFR 52.21 (PSD) do not apply. The potential to emit of VOC is being enforceably restricted to less than one hundred (100) tons per year such that 326 IAC 2-7 does not apply.

326 IAC 2-4.1 (Hazardous Air Pollutants)

The source is not subject to 326 IAC 2-4.1 because the plant was manufactured prior to the applicability date of the rule (July 27, 1997) and the source is not a major source of hazardous air pollutants, as defined in 40 CFR 63. The modification which occurred in 1998 did not in and of itself have the potential to emit greater than ten (10) tons per year of any single HAP or twenty-five (25) tons per year of any combination of HAPs. This modification did not cause source wide limited

potential to emit of an individual HAP or combination of HAPs to exceed the thresholds listed in 326 IAC 2-7-1(22), thus the source does not have major potential to emit for HAPs.

326 IAC 2-6 (Emission Reporting)

This source is subject to 326 IAC 2-6 (Emission Reporting), because the source is located in Marion County and it has the potential to emit more than ten (10) tons per year of NO_X and VOCs. Pursuant to this rule, the owner/operator of the source must submit an emission statement for the source. The statement must be received by April 15 of each year, in accordance with the compliance schedule specified in 326 IAC 2-6 and contain the minimum requirement as specified in 326 IAC 2-6-4. The submittal should cover the period defined in 326 IAC 2-6-2(8).

326 IAC 2-8-4 (FESOP)

(a) Pursuant to this rule, source wide emissions of VOC and SO₂ shall be limited to less than one hundred (100) tons per year such that it does not fall within any of the categories listed in 326 IAC 2-7-2(a) and that assure compliance with all applicable requirements at the time of FESOP issuance (See Emissions Calculations, Appendix A). The following limits shall apply to assure compliance with this rule:

(1) Sulfur Dioxide (SO₂)

The input of No. 2 distillate oil to the three (3) 20.25 MMBtu per hour Nebraska Boilers (EU1, EU2, And EU3) shall be limited to less than 2,588.44 thousand gallons (kgals) per twelve (12) consecutive month period with compliance determined at the end of each month, which is equivalent to SO_2 emissions of 90.1 tons per year. These limits are structured such that when including emissions from insignificant activities, the total source SO_2 emissions remain below one hundred (100) tons per twelve (12) consecutive month period. Compliance with the potential to emit limitation makes 326 IAC 2-7 (Part 70 Permit Program) not applicable.

For purposes of determining compliance based on SO_2 emissions, every one (1) million cubic feet (MMCF) of natural gas shall be equivalent to 0.0086 Kilo-gallons (Kgal) of No. 2 oil.

(2) Volatile Organic Compounds (VOCs)

Pursuant to 326 IAC 8-2-9 (Miscellaneous Metal Parts Operations), VOC emissions from the six (6) independently parallel paint booths (EU4-EU8, and EU10) shall not exceed fifteen (15) pounds per day per paint booth such that 326 IAC 8-2-9 shall not apply. This is equivalent to two and seventy-three hundredths (2.73) tons of VOC per year. These limits are structured such that when including emissions from insignificant activities, the total source VOC emissions remain below one hundred (100) tons per twelve (12) consecutive month period. Compliance with 326 IAC 8-2-9 assures compliance with 326 IAC 2-8-4 and makes 326 IAC 2-7 (Part 70 Permit Program) not applicable.

(b) The amount of any single HAP delivered to the six (6) paint booths (EU4-EU8, and EU10) shall be limited to less than three and four tenths (3.4) tons per twelve (12) consecutive month period with compliance determined at the end of each month. The amount of any combination of HAPs delivered to the paint booths shall be less than eight and two tenths (8.2) tons per twelve (12) consecutive month period with compliance determined at the end of each month. These limits are structured such that when including the emissions of the insignificant activities, the total source single HAP emissions remain below ten (10) tons per twelve (12) consecutive month period and the total source combination HAP emissions remain below twenty-five (25) tons per twelve (12) consecutive month period with compliance determined at the end of each month. Compliance with these limits render the requirements of 326 IAC 2-7 (Part 70 Permit Program).

326 IAC 5-1 (Opacity Limitations)

Pursuant to 326 IAC 5-1-2 (Opacity Limitations), except as provided in 326 IAC 5-1-3 (Temporary Alternative Opacity Limitations), the source is subject to this rule because the source is located in Marion County, except for the area of Washington Township east of Fall Creek and the area of Franklin Township south of Thompson Road and east of Five Points Road. Thus, opacity shall meet the following, unless otherwise stated in this permit:

- Opacity shall not exceed an average of thirty percent (30%) any one (1) six (6) minute (a) averaging period as determined in 326 IAC 5-1-4. Compliance with 40 CFR Part 60.90, Subpart I satisfies the requirement for 326 IAC 5-1-4.
- (b) Opacity shall not exceed sixty percent (60%) for more than a cumulative total of fifteen (15) minutes (sixty (60) readings as measured according to 40 CFR 60, Appendix A, Method 9 or fifteen (15) one (1) minute nonoverlapping integrated averages for a continuous opacity monitor) in a six (6) hour period.

326 IAC 6-1-2 (Particulate Matter)

Pursuant to 326 IAC 6-1-2, EU1- EU8 and EU-10 are not subject to this rule because each emitting unit does not have the potential to emit one hundred (100) tons or more of particulate matter per year or have actual emissions of ten (10) tons or more of particulate matter per year.

State Rule Applicability - Individual Facilities

Boilers

326 IAC 1-7 (Stack Height Provisions)

The three (3) Nebraska Boilers (EU1, EU2, and EU3) each have potential SO₂ emissions in excess of 25 tons per year and were constructed after June 19, 1979. Based on the information supplied in the application stacks 1, 2 and 3 do not comply with the GEP stack height requirements. The GEP stack height for these stacks was calculated to be 95 ft. (the actual stack height listed in the application is 50 ft.) based on the following equation:

S = H + 1.5 (L)where: S = Stack height, (feet)

> Height of supporting or nearby structure (whichever is H =

largest), (feet), 38 ft

L= Lesser dimension (height or width) of the structure chosen for H, (feet), 38 ft

A screening model analysis conducted by OES using the actual stack height of 50 ft. showed no violation of the three (3) hour or twenty four (24) hour National Ambient Air Quality Standard for SO₂. The screening modeling analysis predicted a maximum one hour concentration (175 ug/m³) for one boiler, this concentration was multiplied by 3 to account for the three identical units (525 ug/m³), adjusted to reflect a 3 hour (525 $ug/m^3 \times 0.9 = 472 ug/m^3$) and 24 hour (525 $ug/m^3 \times 0.4 = 201$ ug/m³) averaging times, and compared against the NAAQS for SO₂ (1,300 ug/m³ 3 hour average and 365 ug/m³ for 24 hour average). On February 28, 2003, IDEM, OAQ and OES reviewed 326 IAC 1-7 (Stack Height Provisions) applicability and determined that modeling based on the height of the stacks 1,2,and 3 do not demonstrate a violation of the standard, therefore compliance with NAAQS has been verified. Thus, 326 IAC 1-7 (Stack Height Provisions) is waived for stacks 1,2, and 3 for boilers EU1, EU2, and EU3.

326 IAC 6-2 (Particulate Emission Limitations for Sources of Indirect Heating)

The three (3) Nebraska Boilers (EU1, EU2, and EU3) are subject to the PM limits in 326 IAC 6-2-4. This regulation applies because the boilers are used for indirect heating and were all installed after September 21, 1983. Pursuant to 326 IAC 6-2-4, particulate matter (PM) emissions shall be limited by the following equation

$$Pt = \frac{1.09}{Q^{0.26}}$$

Where Pt = Pounds of PM emitted per million Btu(lb/mmBtu) heat input. Pt is equivalent to 0.37 lbs/mmBtu or 7.49 lbs/hr at maximum heat input capacity.

Q = Total source maximum operating capacity rating in mmBtu per hour heat input. Q is equivalent to 60.75 MMBtu per hour in the case that all three boilers were operating simultaneously.

326 IAC 7-1.1-2 (Sulfur Dioxide Emissions Limitations)

The source is subject to 326 IAC 7-1.1-2, because the potential to emit SO_2 from the three (3) 20.25 MMBtu per hour boilers (EU1, EU2, And EU3) exceeds twenty-five (25) tons per year. Pursuant to this rule, sulfur dioxide emissions from the combustion of distillate (No. 2) oil shall be limited to 0.5 pounds per million Btu (lb/MM Btu) heat input (the equivalent of 0.5% sulfur content).

Paint Booths

40 CFR 52, Subpart P (Particulate)

Pursuant to F097-5444-00100, issued on October 30, 1997and [40 CFR 52, Subpart P], the particulate matter (PM) from the six (6) paint booths (EU4-EU8, EU10) shall be limited by the following:

Interpolation of the data for the process weight rate up to sixty thousand (60,000) pounds per hour shall be accomplished by use of the equation:

$$E = 4.10 P^{0.67}$$
 where $E =$ rate of emission in pounds per hour; and $P =$ process weight rate in tons per hour

326 IAC 6-3-2 (Process Operations)

Pursuant to F097-5444-00100, issued on October 30, 1997 and 326 IAC 6-3-2(d), particulate from the six (6) paint booths (EU4-EU8, and EU10) shall be controlled by a dry particulate filter, and the Permittee shall operate the control device in accordance with manufacturer's specifications.

326 IAC 8-2-9 (Miscellaneous Metal Parts Coating Operations)

This regulation will apply to the six (6) paint booths (EU4-EU8, and EU10) separately, if the actual VOC emissions exceed fifteen (15) pounds per day per emission unit. This regulation is potentially applicable since these facilities are located in Marion county and are being used to coat metal parts under the Standard Industrial Classification Code of major group 36. The FESOP limits the VOC emissions for each booth separately to less than 15 pounds per day each (which is equivalent to 2.73 tons per year each) such that Miscellaneous Metal Parts Regulation 326 IAC 8-2-9 shall not apply. According to source usage records these booths do not emit more than fifteen (15) pounds of VOCs per day per booth.

<u>Degreaser</u>

326 IAC 8-3-2 (Cold Cleaner Operation)

The source is subject to 326 IAC 8-3-2 because the source is located in Marion County, performs organic solvent degreasing operations which existed prior to January 1, 1980, and has the potential source wide VOC emissions of greater than one hundred (100) tons per year. This regulation applies the Safety Kleen degreasing operation. The source shall ensure that the operation requirements contained within the rule are met.

326 IAC 8-3-5 (Cold Cleaner Degreaser Operation and Control)

The source is subject to 326 IAC 8-3-5 because the source is located in Marion County, performs organic solvent degreasing operations which existed prior to January 1, 1980, and has the potential VOC emissions of greater than one hundred (100) tons per year. This regulation applies to the Safety Kleen degreasing operation. The source shall ensure that the control equipment requirements contained within the rule are met.

Welding

326 IAC 6-3-2 (Process Operations)

The source is not subject to 326 IAC 6-3-2 because the welding operations performed by the source consume less than six hundred twenty-five (625) pounds of rod or wire per day.

Compliance Requirements

Permits issued under 326 IAC 2-8 are required to ensure that sources can demonstrate compliance with applicable state and federal rules on a more or less continuous basis. All state and federal rules contain compliance provisions, however, these provisions do not always fulfill the requirement for a more or less continuous demonstration. When this occurs IDEM, OAQ, in conjunction with the source, must develop specific conditions to satisfy 326 IAC 2-8-4. As a result, compliance requirements are divided into two sections: Compliance Determination Requirements and Compliance Monitoring Requirements.

Compliance Determination Requirements in Section D of the permit are those conditions that are found more or less directly within state and federal rules and the violation of which serves as grounds for enforcement action. If these conditions are not sufficient to demonstrate continuous compliance, they will be supplemented with Compliance Monitoring Requirements, also Section D of the permit. Unlike Compliance Determination Requirements, failure to meet Compliance Monitoring conditions would serve as a trigger for corrective actions and not grounds for enforcement action. However, a violation in relation to a compliance monitoring condition will arise through a source's failure to take the appropriate corrective actions within a specific time period.

All compliance requirements from previous approvals were incorporated into this FESOP. The compliance monitoring requirements applicable to this source are as follows:

- (1) The three (3) Nebraska Boilers (EU1, EU2, and EU3) have applicable compliance monitoring conditions as specified below:
 - (a) Visible emissions notations of the exhaust stack from the boilers shall be performed once per shift during normal daylight operations when burning fuel oil. A trained employee will record whether emissions are normal or abnormal. For processes operated continuously "normal" means those conditions prevailing, or expected to prevail, eighty percent (80%) of the time the process is in operation, not counting startup or shut down time. In the case discontinuous operations, readings shall be taken during that part of the operation that would normally be expected to cause the greatest emissions. A trained employee is an employee who has worked at the plant at least one (1) month and has been trained in the appearance and characteristics of normal visible emissions for that specific process. The Compliance Response Plan for this unit shall contain troubleshooting contingency and response steps for when an abnormal emission is observed.

These monitoring conditions are necessary in order to ensure compliance with 326 IAC 2-8 (FESOP) and 326 IAC 6-2-4.

- (2) The six (6) Paint Booths (EU4-EU8, and EU10) have applicable compliance monitoring conditions as specified below:
 - (a) Daily inspections shall be performed to verify the placement, integrity and particle loading of the filters. To monitor the performance of the dry filters, weekly observations shall be made of the overspray from the surface coating booth stacks (S4, S5, S6, S7, S8, and S10) while one or more of the booths are in operation.

The Compliance Response Plan shall be followed whenever a condition exists which should result in a response step. Failure to take response steps in accordance with Section C - Compliance Response Plan -Preparation, Implementation, Records, and Reports, shall be considered a violation of this permit.

- (b) Monthly inspections shall be performed of the coating emissions from the stack and the presence of overspray on the rooftops and the nearby ground. The Compliance Response Plan for this unit shall contain troubleshooting contingency and response steps for when a noticeable change in overspray emission, or evidence of overspray emission is observed. The Compliance Response Plan shall be followed whenever a condition exists which should result in a response step. Failure to take response steps in accordance with Section C - Compliance Response Plan -Preparation, Implementation, Records, and Reports, shall be considered a violation of this permit.
- (c) Additional inspections and preventive measures shall be performed as prescribed in the Preventive Maintenance Plan.

These monitoring conditions are necessary in order to ensure compliance with 326 IAC 2-8 (FESOP) and 326 IAC 6-3, and avoid becoming a major PSD source under 326 IAC 2-2.

Conclusion

The operation of avionic equipment manufacturing shall be subject to the conditions of the attached proposed FESOP No.: F097-14722-00100.
