Notice of Decision – Approval

Please be advised that on behalf of the Commissioner of the Department of Environmental Management, I have issued a decision regarding the enclosed matter. Pursuant to 326 IAC 2, this approval was effective immediately upon submittal of the application.

If you wish to challenge this decision, IC 4-21.5-3-7 requires that you file a petition for administrative review. This petition may include a request for stay of effectiveness and must be submitted to the Office of Environmental Adjudication, 100 North Senate Avenue, Government Center North, Room 1049, Indianapolis, IN 46204, **within eighteen (18) calendar days from the mailing of this notice**. The filing of a petition for administrative review is complete on the earliest of the following dates that apply to the filing:

- (1) the date the document is delivered to the Office of Environmental Adjudication (OEA);
- (2) the date of the postmark on the envelope containing the document, if the document is mailed to OEA by U.S. mail; or
- (3) The date on which the document is deposited with a private carrier, as shown by receipt issued by the carrier, if the document is sent to the OEA by private carrier.

The petition must include facts demonstrating that you are either the applicant, a person aggrieved or adversely affected by the decision or otherwise entitled to review by law. Please identify the permit, decision, or other order for which you seek review by permit number, name of the applicant, location, date of this notice and all of the following:

- (1) the name and address of the person making the request;
- (2) the interest of the person making the request;
- (3) identification of any persons represented by the person making the request;
- (4) the reasons, with particularity, for the request;
- (5) the issues, with particularity, proposed for considerations at any hearing; and
- (6) identification of the terms and conditions which, in the judgment of the person making the request, would be appropriate in the case in question to satisfy the requirements of the law governing documents of the type issued by the Commissioner.

The application from Dana Hose and Tubing Products, Inc. was received, received on June 7, 2005, has been reviewed. The operating name has changed from Epic Technical Group to Dana Hose and Tubing Products, Inc. Based on the data submitted and the provisions in 326 IAC 2-1.1-3, it has been determined that the following brazing furnace and metal inert gas welding stations, to be located at 1501 Wohler, Angola, Indiana, remains classified as exempt from air pollution permit requirements:

- (a) One (1) brazing furnace with a heat input capacity of 0.055 million Btu per hour; and
- (b) Ten (10) Metal Inert Gas (MIG) welding stations using carbon steel-AWS E70s and stainless-AWS 5.9-93 wire, with a maximum hourly consumption of 0.23 pounds per hour for each station.

This exemption is a revision of the first air approval (151-4207-00026) issued to this source.

An application or notification shall be submitted in accordance with 326 IAC 2 to the Office of Air Quality (OAQ) if the source proposes to construct new emission units, modify existing emission units, or otherwise modify the source.
