Schwab Corporation was issued a Part 70 Operating Permit No. T123-15952-00018 for a stationary metal safe and file cabinet manufacturing facility, located at 4630 E SR 66, Cannelton, in Perry County.

On August 8, 2009, the source applied to OAQ with a review request concerning the intention of Schwab Corporation to change material specifications as follows:


- 1) Discontinue application of: Polane SD Polyurethane Enamel
- 2) Begin application of: Permaclad High Solids Baking Enamel

OAQ has evaluated the submitted calculations which shows that the maximum emission increase associated with this change would be 1.21 tons per year of HAP. This increase does not necessitate any permit modification.

There will be no revision to the permit at this time. All conditions of the permit shall remain unchanged and in effect.
