

Dear Mr. Wehrkamp:

On January 11, 2010, Cummins Industrial Center submitted a letter notifying the Office of Air Quality (OAQ) that they are no longer using Kamatsu Yellow (9720YWA-1). The source is now using Natural Yellow instead. Kamatsu Yellow contained Nickel Compounds that may have triggered the requirements of 40 CFR 64, Subpart HHHHHH Paint Stripping and Miscellaneous Surface Coating. The source no longer uses coatings that contain target HAPs as defined in the rule.
