Dear Ms. Keon:

Boral Bricks, was issued a Part 70 permit renewal on August 31, 2007, for the operation of a stationary brick manufacturing source. An application from the source requesting that the permit be updated to indicate a modification was received on January 19, 2010. The request states that the Permittee plans to add one (1) dust collector to the facility's existing texturing line to control employee exposure levels. The texturing line is part of the forming and setting operations where sand is applied by sprinkling or pouring on the brick column where the residual is collected and recycled. The purpose of the dust collector is mainly for employee comfort and is not an OSHA requirement. The dust collector will be located in the building and vent to the outside.

No sections in the Part 70 permit are affected by the change. All conditions of the permit shall remain unchanged and in effect. Please attach a copy of this letter to the front of the original permit.
