On March 15, 2010, Prairie View Recycling and Disposal Facility submitted a letter informing the Office of Air Quality (OAQ) of their intention to add a collection point that will connect to a previously installed leachate clean-out riser.

The remote well will be installed by the dripleg and vacuum from the dripleg will be used to remove any gas and/or odors from the leachate clean-out riser located next to the 18" riser (LCR4).

The addition of the collection point will not result in an increase in emissions.

All conditions of the permit shall remain unchanged and in effect. Please attach a copy of this letter to the front of the original permit.
