Please be advised that on behalf of the Commissioner of the Department of Environmental Management, I have issued a decision regarding the enclosed matter. Pursuant to 326 IAC 2, this approval was effective immediately upon submittal of the application.

If you wish to challenge this decision, IC 4-21.5-3-7 requires that you file a petition for administrative review. This petition may include a request for stay of effectiveness and must be submitted to the Office of Environmental Adjudication, 100 North Senate Avenue, Government Center North, Suite N 501E, Indianapolis, IN 46204, within eighteen (18) calendar days from the mailing of this notice. The filing of a petition for administrative review is complete on the earliest of the following dates that apply to the filing:

- (1) the date the document is delivered to the Office of Environmental Adjudication (OEA);
- (2) the date of the postmark on the envelope containing the document, if the document is mailed to OEA by U.S. mail; or
- (3)The date on which the document is deposited with a private carrier, as shown by receipt issued by the carrier, if the document is sent to the OEA by private carrier.

The petition must include facts demonstrating that you are either the applicant, a person aggrieved or adversely affected by the decision or otherwise entitled to review by law. Please identify the permit, decision, or other order for which you seek review by permit number, name of the applicant, location, date of this notice and all of the following:

- (1) the name and address of the person making the request;
- (2) the interest of the person making the request;
- (3)identification of any persons represented by the person making the request;
- the reasons, with particularity, for the request: (4)
- (5) the issues, with particularity, proposed for considerations at any hearing; and
- (6)identification of the terms and conditions which, in the judgment of the person making the request, would be appropriate in the case in question to satisfy the requirements of the law governing documents of the type issued by the Commissioner.

Dear Mr. Branson:

The application from DBA: Morgan County Funeral Home, received on June 23, 2010, has been reviewed. Based on the data submitted and the provisions in 326 IAC 2-1.1-3, it has been determined that the following stationary human crematorium located at 45 East High Street, Mooresville, IN 46158 is classified as exempt from air pollution permit requirements:

- One (1) multiple chamber cremation retort for human remains, identified as EU-01, (a) constructed in 2010 with maximum capacity of 150 pounds per hour, using natural gas at a heat input rate of 1.5 MMBtu per hour and exhausting through one (1) stack.
- Fugitive emissions from paved roads and parking lots. (b)

The following conditions shall be applicable:

- Pursuant to 326 IAC 5-1-2 (Opacity Limitations), except as provided in 326 IAC 5-1-3 (Temporary 1. Alternative Opacity Limitations), opacity shall meet the following, unless otherwise stated in this registration:
 - Opacity shall not exceed an average of forty percent (40%) in any one (1) six (6) minute (a) averaging period as determined in 326 IAC 5-1-4.
 - Opacity shall not exceed sixty percent (60%) for more than a cumulative total of fifteen (b) (15) minutes (sixty (60) readings as measured according to 40 CFR 60, Appendix A, Method 9 or fifteen (15) one (1) minute nonoverlapping integrated averages for a continuous opacity monitor) in a six (6) hour period.
- 2. Pursuant to 326 IAC 4-2-2, the crematory incinerator (human cremation retort) shall:
 - (1) Consist of primary and secondary chambers or the equivalent;
 - Be equipped with a primary burner unless burning only wood products; (2)
 - Comply with 326 IAC 5-1 (Opacity Limitations) and 326 IAC 2 (Permit Review Rules); (3)
 - Be maintained, operated, and burn waste in accordance with the manufacturer's (4) specifications or an operation and maintenance plan approved by the Administrator;
 - (5)The crematory incinerator shall not emit particulate matter in excess of five-tenths (0.5) pound of particulate matter per one thousand (1,000) pounds of dry exhaust gas under standard conditions corrected to fifty percent (50%) excess air because the maximum solid waste capacity is less than two hundred (200) pounds per hour;



- (6) If any of the above requirements (1) through (5) are not met, then the owner or operator shall stop charging the incinerator until adjustments are made that address the underlying cause of the deviation; and
- (7) The incinerator is exempt from requirement (5) if subject to a more stringent particulate matter emissions limit in 40 CFR 52 Subpart P, State Implementation Plan for Indiana.
- (8) The owner or operator of the incinerator must make the manufacturer's specifications or the operation and maintenance plan available to the department upon request.
- 3. Pursuant to 326 IAC 6-4 (Fugitive Dust Emissions Limitations), the source shall not allow fugitive dust to escape beyond the property line or boundaries of the property, right-of-way, or easement on which the source is located, in a manner that would violate 326 IAC 6-4

On June 23, 2010, the Office of Air Quality (OAQ) received an application from Morgan County Funeral Home related to the construction and operation of a new human crematory.

Existing Approvals

There have been no previous approvals issued to this source.

The source is located in Morgan County.

(a) Ozone Standards

Volatile organic compounds (VOC) and Nitrogen Oxides (NOx) are regulated under the Clean Air Act (CAA) for the purposes of attaining and maintaining the National Ambient Air Quality Standards (NAAQS) for ozone. Therefore, VOC and NOx emissions are considered when evaluating the rule applicability relating to ozone. Morgan County has been designated as attainment or unclassifiable for ozone. Therefore, VOC and NOx emissions were reviewed pursuant to the requirements for Prevention of Significant Deterioration (PSD), 326 IAC 2-2.

Morgan County has been classified as attainment for $PM_{2.5}$. On May 8, 2008 U.S. EPA promulgated the requirements for Prevention of Significant Deterioration (PSD) for $PM_{2.5}$ emissions. These rules became effective on July 15, 2008. Indiana has three years from the publication of these rules to revise its PSD rules, 326 IAC 2-2, to include those requirements. The May 8, 2008 rule revisions require IDEM to regulate PM10 emissions as a surrogate for $PM_{2.5}$ emissions until 326 IAC 2-2 is revised.

(c) Other Criteria Pollutants

Morgan County has been classified as attainment or unclassifiable in Indiana for all criteria pollutants. Therefore, these emissions were reviewed pursuant to the requirements for Prevention of Significant Deterioration (PSD), 326 IAC 2-2.

Fugitive Emissions

The fugitive emissions of criteria pollutants and hazardous air pollutants are counted toward the determination of 326 IAC 2-1.1-3 (Exemptions) applicability.

Background and Description of Emission Units and Pollution Control Equipment

The Office of Air Quality (OAQ) has reviewed an application, submitted by Morgan County Funeral Home on June 23, 2010, relating to the installation and operation of One (1) multiple chamber cremation retort for human remains, identified as EU-01 with maximum capacity of 150 pounds per hour, using natural gas at a heat input rate of 1.5 MMBtu per hour and exhausting through one (1) stack.

Enforcement Issues

There are no pending enforcement actions related to this source.

Federal Rule Applicability Determination

New Source Performance Standards (NSPS)

- (a) The requirements of the New Source Performance Standard for Incinerators, 40 CFR 60, Subpart E (326 IAC 12), are not included in the permit, since the human cremation retort has a charging rate of less than fifty (50) tons per day and does not burn refuse consisting of more than 50% municipal type waste.
- (b) The requirements of the New Source Performance Standard for Municipal Waste Combustors for Which Construction is Commenced After December 20, 1989 and on or Before September 20, 1994, 40 CFR 60, Subpart Ea (326 IAC 12), are not included in this permit, because the human cremation retort was constructed after September 20, 1994. In addition, the human cremation retort is not designed to burn municipal solid waste. The human cremation retort is designed to burn only type 4 waste, which is pathological waste consisting of 100% animal and/or human tissue.
- (c) The requirements of the New Source Performance Standard for Large Municipal Waste Combustors for Which Construction is Commenced After September 20, 1994, 40 CFR 60, Subpart Eb (326 IAC 12), are not included in this permit, because the human cremation retort is not designed to burn municipal solid waste. The human cremation retort is designed to burn only type 4 waste, which is pathological waste consisting of 100% animal and/or human tissue.
- (d) The requirements of the New Source Performance Standard for Hospital/Medical/Infectious Waste Incinerators for Which Construction is Commenced After January 20, 1996, 40 CFR 60, Subpart Ec (326 IAC 12), are not included in this permit, because the human cremation retort is not a hospital/medical/infectious waste incinerator as defined in 40 CFR 60.51c.
- (e) The requirements of the New Source Performance Standard for Small Municipal Waste Combustion Units for Which Construction is Commenced After August 30, 1999 or for Which Modification or Reconstruction is Commenced After June 6, 2001, 40 CFR 60, Subpart AAAA (326 IAC 12), are not included in this permit, because the human cremation retort is not designed to burn municipal solid waste. The human cremation retort is designed to burn only type 4 waste, which is pathological waste consisting of 100% animal and/or human tissue.
- (f) The requirements of the New Source Performance Standard for Commercial and Industrial Solid Waste Incineration Units for Which Construction is Commenced After November 30, 1999 or for Which Modification or Reconstruction is Commenced on or After June 1, 2001, 40 CFR 60, Subpart CCCC (326 IAC 12), are not included in this permit, because the human cremation retort is not a commercial and industrial solid waste incineration (CISWI) unit as defined in 40 CFR 60.2265.
- (g) The requirements of the New Source Performance Standard for Other Solid Waste Incineration Units, 40 CFR 60, Subpart EEEE (326 IAC 12), are not included in this permit. The human cremation retort does not meet the definition of a small municipal waste combustion unit or an institutional waste incineration unit provided in 40 CFR 60.2977.
- (h) There are no other New Source Performance Standards (NSPS)(326 IAC 12 or 40 CFR Part 60) included in the permit.

National Emission Standards for Hazardous Air Pollutants (NESHAP)

(i) The requirements of the National Emissions Standards for Hazardous Air Pollutants (NESHAPs) for Hazardous Waste Combustors (40 CFR 63, Subpart EEE, 326 IAC 20-28) are not included in this permit, because each of the human cremation retort is not considered a hazardous waste incinerator as defined in 40 CFR 63.1201.

(j) There are no other National Emission Standards for Hazardous Air Pollutants (NESHAPs) (326 IAC 14, 326 IAC 20 and 40 CFR Part 63) included in the permit.

Compliance Assurance Monitoring (CAM)

(k) Pursuant to 40 CFR 64.2, Compliance Assurance Monitoring (CAM) is not included in the permit, because the unlimited potential to emit of the source is less than the Title V major source thresholds and the source is not required to obtain a Part 70 or Part 71 permit.

State Rule Applicability Determination

The following state rules are applicable to the source:

326 IAC 2-1.1-3 (Exemptions)

Exemption applicability is discussed under the Permit Level Determination – Exemption section above.

326 IAC 2-4.1 (Major Sources of Hazardous Air Pollutants (HAP))

The potential to emit of any single HAP is less than ten (10) tons per year and the potential to emit of a combination of HAPs is less than twenty-five (25) tons per year. Therefore, this source is an area source under Section 112 of the Clean Air Act (CAA) and not subject to the provisions of 326 IAC 2-4.1.

326 IAC 2-6 (Emission Reporting)

Pursuant to 326 IAC 2-6-1, this source is not subject to this rule, because it is not required to have an operating permit under 326 IAC 2-7 (Part 70), it is not located in Lake, Porter, or LaPorte County, and it does not emit lead into the ambient air at levels equal to or greater than 5 tons per year. Therefore, 326 IAC 2-6 does not apply.

326 IAC 5-1 (Opacity Limitations)

Pursuant to 326 IAC 5-1-2 (Opacity Limitations), except as provided in 326 IAC 5-1-3 (Temporary Alternative Opacity Limitations), opacity shall meet the following, unless otherwise stated in this permit:

- (1) Opacity shall not exceed an average of forty percent (40%) in any one (1) six (6) minute averaging period as determined in 326 IAC 5-1-4.
- (2) Opacity shall not exceed sixty percent (60%) for more than a cumulative total of fifteen (15) minutes (sixty (60) readings as measured according to 40 CFR 60, Appendix A, Method 9 or fifteen (15) one (1) minute nonoverlapping integrated averages for a continuous opacity monitor) in a six (6) hour period.

326 IAC 6-4 (Fugitive Dust Emissions Limitations)

The source is subject to the requirements of 326 IAC 6-4, because the paved roads and parking lots at the source have the potential to emit fugitive particulate emissions. Pursuant to 326 IAC 6-4 (Fugitive Dust Emissions Limitations), the source shall not allow fugitive dust to escape beyond the property line or boundaries of the property, right-of-way, or easement on which the source is located, in a manner that would violate 326 IAC 6-4.

326 IAC 6-5 (Fugitive Particulate Matter Emission Limitations)

The source is not subject to the requirements of 326 IAC 6-5, because the source does not have potential fugitive particulate emissions greater than 25 tons per year. Therefore, 326 IAC 6-5 does not apply.

326 IAC 8-1-6 (VOC Rules: General Reduction Requirements for New Facilities)

The emission unit at this source is not subject to the requirements of 326 IAC 8-1-6, since the unlimited VOC potential emissions from each emission unit is less than twenty-five (25) tons per year.

Incinerator

326 IAC 4-2-2 Incinerators

Pursuant to 326 IAC 4-2-2, the crematory incinerator (human cremation retort) shall:

- (1) Consist of primary and secondary chambers or the equivalent;
- (2) Be equipped with a primary burner unless burning only wood products;
- (3) Comply with 326 IAC 5-1 (Opacity Limitations) and 326 IAC 2 (Permit Review Rules);
- (4) Be maintained, operated, and burn waste in accordance with the manufacturer's specifications or an operation and maintenance plan approved by the Administrator;
- (5) The crematory incinerator shall not emit particulate matter in excess of five-tenths (0.5) pound of particulate matter per one thousand (1,000) pounds of dry exhaust gas under standard conditions corrected to fifty percent (50%) excess air because the maximum solid waste capacity is less than two hundred (200) pounds per hour;
- (6) If any of the above requirements (1) through (5) are not met, then the owner or operator shall stop charging the incinerator until adjustments are made that address the underlying cause of the deviation; and
- (7) The incinerator is exempt from requirement (5) if subject to a more stringent particulate matter emissions limit in 40 CFR 52 Subpart P, State Implementation Plan for Indiana.
- (8) The owner or operator of the incinerator must make the manufacturer's specifications or the operation and maintenance plan available to the department upon request.
- 326 IAC 6-2 (Particulate Emission Limitations for Sources of Indirect Heating)
 326 IAC 6-2 applies to sources of indirect heating. The human cremation retort is not considered a source of indirect heating. Therefore, 326 IAC 6-2 does not apply.
- 326 IAC 6-3 (Particulate Emission Limitations for Manufacturing Processes)

 Pursuant to 326 IAC 6-3-1(b)(2), incineration is exempt. Therefore, 326 IAC 6-3 does not apply to the human cremation retort.

326 IAC 9-1 (Carbon Monoxide Emission Limits)

This stationary source, constructed after the applicability date of March 21, 1972, is not subject to the requirements of 326 IAC 9-1-2(a)(3), since the human cremation retort only burns pathological waste and does not burn refuse consisting of more than 50 percent municipal type waste (household, commercial/retail, and/or institutional waste).

326 IAC 11-6 (Hospital/Medical/Infectious Waste Incinerators)

The human cremation retort is not subject to the requirements of 326 IAC 11-6, since it is considered a pathological waste combustor and not a hospital/medical/infectious waste combustor.

326 IAC 11-7 (Emission Limitations for Municipal Waste Combustors)

The human cremation retort is not subject to the requirements of 326 IAC 11-7, since it is considered a pathological waste combustor and not municipal waste combustor.

326 IAC 11-8 (Commercial and Industrial Solid Waste Incineration Units)

The human cremation retort is not considered a Commercial and Industrial Incineration Unit.

Therefore, 326 IAC 11-8 does not apply.

Conclusion and Recommendation

Unless otherwise stated, information used in this review was derived from the application and additional information submitted by the applicant. An application for the purposes of this review was received on June 23, 2010.

The construction and operation of this source shall be subject to the conditions of the attached proposed Exemption No. E109-29385-00061. The staff recommends to the Commissioner that this be approved.
