Griffin Industries was issued a Federally Enforceable State Operating Permit (FESOP) No. F005-23269-00064 on December 28, 2007 for operation of a stationary animal by-products and bakery by-products recycling company, located at 345 Water St, Columbus, Indiana 47201.

On December 20, 2010, the source notified IDEM, OAQ that Griffin Industries, Inc. had merged with Darling International, Inc effective December 17, 2010. Griffin Industries, Inc. will continue to operate with total responsibility and accountability for compliance with all Federal, State, and Local environmental rules, and resulting permitting. Griffin Industries, Inc. believes the merger does not constitute a Transfer of Ownership, and therefore does not necessitate any needed permit transfer, modification, or reissuance action for the subject operating permit. Griffin Industries, Inc. also states that no equipment changes have been made since the issuance of FESOP No. F005-23269-00064.

IDEM concurs that the merger does not constitute any changes to the permit.

No revision to the permit was necessary to accommodate this request. All conditions of the permit shall remain unchanged and in effect.
