RE: Review Request

Mr. Mann:

Saint-Gobain Containers, located at 524 East Center Street in Dunkirk, Indiana, submitted a Review Request on January 24, 2011. The letter was submitted to determine if Saint-Gobain Containers requires air pollution permit modifications for replacing a transformer associated with Furnace one.

Specifically, the modification involves the following:

- Replace existing transformer for Furnace No. 1 at Saint-Gobain Containers' Dunkirk facility.

The Permittee has stated in this review request that this modification will not increase the formation and subsequent emissions of any regulated pollutants and will not affect production capacity. IDEM, OAQ has not reviewed any additional information as part of this review.

IDEM has determined that a modification to the existing permit will not be necessary as the replacement of the transformer with like equipment will not produce any additional emissions and will not require a descriptive change in the permit.
