On July 26, 2006 IDEM was notified by Navistar, Inc. (International Truck & Engine) that the stationary vehicle and parts coating operation, located at 2911 Meyer Road, Fort Wayne, Indiana was operating under the provisions of 326 IAC 2-10 (Permit by Rule). On November 29, 2012, the Office of Air Quality (OAQ) received a letter from the source stating that Navistar, Inc. (International Truck & Engine) is no longer operating under Permit by Rule Status since it has ceased operations.

IDEM, OAQ acknowledges that Navistar, Inc. (International Truck & Engine) is no longer operating under the provision of 326 IAC 2-10 (Permit by Rule) since it has ceased operations. Please be advised, if there is a need in the future to operate any units at this source, construction and operation approval will be necessary pursuant to Indiana's New Source Review regulations.
