Dear Ms. Elzinga:

Hydrite Chemical Co. was issued a Minor Source Operating Permit No. 167-29848-00069 for construction and operation of a stationary food grade ammonium, sodium, and magnesium bisulfite production facility, located at 1330 Lockport Road, Terre Haute, IN 47802.

On December 04, 2012, the source notified OAQ that it intends to construct an above ground vertical storage tank, identified as T05001, with a maximum capacity of one (1) million gallons, to store Ammonium Thiosulfate solution 60. Ammonium Thiosulfate is an inorganic salt solution and does not cause the emission of any regulated pollutants. Therefore, the source is not required to obtain a permit to construct this storage tank.
