Dear Mr. Sulc:

On September 10, 2013, the Office of Air Quality (OAQ) received a letter from Nucor Steel requesting an extension to the 18-month construction deadline required as part of the approval for Significant Source Modification No. 107-31415-00038 issued on May 15, 2012. This extension was requested due to the current state of the economy and the length of time the contract negotiations took. The significant source modification was issued for the construction of the following emission unit:

(a) One (1) new cooling tower with a capacity of 1,840 gallons per minute.

No new state and federal rules are applicable to this emission unit.

Therefore, OAQ agrees to extend the 18 month construction deadline by an additional 18 months, and will extend the timing to May 15, 2015. If construction does not commence on or before this date, additional approval from the Office of Air Quality shall be required.
